Part-time School Counsellor

Responsible to: Assistant Head Teacher (Pastoral and Mental Health Lead)

Main Purpose

To support the positive mental health of some of the most vulnerable students in Wadham School. To provide small group support to facilitate positive mental health.

To support Wadham Staff who may be experiencing personal difficulties and mental health and wellbeing issues.

To provide training to staff and parents on promoting positive mental health, identifyinging mental health needs and supporting a mental health crisis.

Main Duties and Responsibilities

- To manage own case load in conjunction with the Assistant Head Teacher
- To create training programmes for staff and parents which brings positive change and encourages self-reflection to support a healthy outcome in times of mental health needs.
- To manage a clinical caseload within the Health & Care Professions Council or equivalent body ethical framework, including keeping case files and suitably codified attendance records, confidentially and securely.
- To support staff and students when the school is faced with critical incidents.
- To track and monitor the effectiveness of support provided.
- To work closely with the Pastoral and Safeguarding team.
- To attend all pastoral and Safeguarding Team meetings.
- To provide reports and evidence for EHCPs, Annual reviews, TAFs, EHA requests, Core group meetings, ICPCs, RCPCs etc.
- To refer without delay all safeguarding issues to the Designated Safeguarding Lead.
- To provide a range of suitably need-tailored counselling and therapy techniques in order to work therapeutically and innovatively in addressing student's needs.
- To work collaboratively with colleagues.
- To ascertain and publicise relevant sources of additional support available to students and staff in an appropriate way to allows inclusion.
- In agreement with the school, to attend regular monthly clinical supervision in line with the DfE Guidance 'Counselling in Schools'.
- To collaborate with Senior Leaders in designing, leading, implementing and monitoring the whole school strategy on promotion of a positive mental health and wellbeing ethos.
- Lead on staff training on promoting positive mental health.
- To undertake any reasonable additional duties required by the Headteacher.

Experience and abilities

- Training in child development and mental health and an understanding of what can be done to provide help and support to those who need it.
- Good listening skills and an approachable manner that encourages a climate for safe and trusting relationships.
- Evidence of managing a clinical caseload within an educational or Health and Social Carel setting, including maintaining appropriate case records.
- Evidence of outcome-based evaluation of counselling outcomes.
- Evidence of working under pressure, whilst remaining calm.
- Evidence of provision of a range of therapies, utilised according to need.
- Evidence of ability to work collaboratively in a multi-professional setting.
- Awareness of current relevant safeguarding guidelines including KCSIE 2023.
- Ability to balance competing priorities.
- Ability to build strong professional relationships with students, staff and parents.
